

MINUTES OF THE HUTCHINSON ISLAND PRESERVATION INITIATIVE MEETING
HELD TUESDAY, FEBRUARY 11, 2020

The February 11, 2020 Hutchinson Island Preservation Initiative (HIPI) meeting was called to order at 4:20 p.m. by President Ralph Jones. Board members present were Jim Foley, Treasurer, Barbara Seaton, Director, Paul Laura, Environmental Director, Elizabeth Farrar, External Communications Co-Director, Sue Foley, HIPI member and advisor to the board, Patty Jones, Secretary, and participating by phone were Hilarie Davis, External Communications Co-Director, and Dottie Lanci, Vice President. Larry Gray, HIPI member was also in attendance.

APPROVAL OF MINUTES: Mr. Laura moved, seconded by Ms. Seaton, to approve the minutes of the June 12, 2019 meeting. All present voted aye, the motion passed unanimously.

REPORT BY MS. FARRAR ON ST. LUCIE PRESIDENT'S COUNCIL REQUEST: Ms.

Farrar reported that she has been attending the President's Council meetings in St. Lucie County north of the roundabout on the Island. She reported that they are having a severe beach erosion problem and are looking to impose an MSTU to help fund beach nourishment. She stated that we on the Island in Martin County have twelve (12) beach accesses with a four (4) mile distance from the roundabout. Four (4) miles north of the roundabout in St Lucie County there are only two (2) or three (3) beach accesses. The Army Corps says they have no funds to conduct beach restoration in St. Lucie County. The cost identified by the President's Council to replenish the beach is \$17 per cubic yard of sand.

The President's Council has investigated alternative means for beach restoration and they claim they have found a process which would cost \$1.52 per cubic yard of sand. It's called "Streamside" out of Colorado and is working with fresh water sediment collection for bank erosion. However, they have had a pilot program in Galveston. The website is:

This is for restoration of sand beaches and involves equipment similar to a backhoe and a conveyor belt that would require manned safety to keep people from getting too close and possibly getting hurt.

The President's Council has also investigated the Dick Holmberg Technologies method. Ms. Farrar explained that Dick Holmberg is now 83 yrs. old and this is technology he touted in the 80's and 90's. He is not a credentialed scientist but espouses a method of collecting water and discharging the sediment to restore beaches which has been tested in the Great Lakes and Saudi Arabia.

President's Council is seeking HIPI's support and endorsement with the Army Corps to seek these alternate methods which the President's Council believes will be so cheap. They also spoke to E.J. Ewing of Sailfish Point to seek their support.

Mr. Laura reported that FEMA did approve and distribute 9 million dollars for beach restoration to St. Lucie County over the past six (6) months. Mr. Laura said he thinks the President's Council is taking the wrong approach going through the Army Corps which is very bureaucratic and difficult. He suggested that they should seek grant funds and work with the political system such as State Rep. Brian Mast.

Ms. Farrar said the President's Council has been voracious in seeking her out for HIPI's formal support on these alternate means for beach nourishment. Everyone present and Hilarie agreed that using "breakwater" methods to restore beaches did not bring sand back to the beaches and proved to be unsuccessful.

Mr. Foley moved, seconded by Mr. Laura, HIPI completely supports preserving our beaches. In light of climate change predictions, we agree that finding a more cost effective method for beach restoration is a good idea. However, HIPI is not in a position to endorse any one of these methods. Upon roll call vote, the motion carried unanimously.

Mr. Laura stated that Allen Herskowitz, Board Chair of the Florida Oceanographic, would be an excellent person to speak to about this, also, Dwayne DeVries of NEPA, National Estuary Program Association.

Ms. Farrar reported the next meeting of the President's Council is March 17th when the Army Corps and St Lucie County representatives will be guest speakers regarding Federal beach project update. Meeting location is the Island Club, 10410 Ocean Drive.

(Even though not reported at the meeting, the President's Council next meeting if February 18th, same location, speaker is Jane Cornett, Becker-Poliakoff, annual legal review.)
