We're Still Here and Ready To Get Back In Action!

Hello Friends! We've missed you, but we've been staying home and staying safe. We hope you have, too.

The Hutchinson Island Preservation Initiative, HIPI, is a Florida nonprofit corporation. Our mission is to preserve and protect Hutchinson Island in Martin County.

The organization started in 2018 when a group of Hutchinson Island property owners came together with a shared interest in preserving and protecting the natural beauty of Hutchinson Island and ensuring Hutchinson Island property owners are informed about issues that may affect them, their property or the island.

We were just getting started as a new organization, when the Covid pandemic brought most activity to a halt. We cancelled our second annual membership meeting and held only a brief annual meeting this March via Zoom, primarily to announce the election of new officers.

Now that vaccines are available, we're hoping and planning for a return to normal activities soon. We are ready to get back to work!

We're working to bring our website up-to-date and looking forward to sharing information about issues that may affect Hutchinson Island. Look for a return of our monthly newsletters and regular updates posted on our social media pages.

CALL TO ACTION:

Lake O Blue-Green Algae at Critical Levels

As of April 21, the level of toxic algae (cyanobacteria/blue-green algae) at the Port Mayaca dam in Lake Okeechobee was 120ppb (parts per billion). Levels above 8ppb is considered highly toxic.

As we enter the rainy season, Lake O is at 13.9 feet, four feet higher than the recommended level. The Army Corps temporarily has postponed discharges to the St. Lucie River due to the algae, but discharges continue to the Caloosahatchee River.

The Rivers Coalition and our U.S. House Rep. Brian Mast ask for an urgent action by every citizen to contact the Army Corps of Engineers via letter, email or phone call. Citizens are encouraged to ask the Corps to

1. Stop discharges to the St. Lucie River/C44 Canal
2. Adopt the St. Lucie Ecology Plan 4C-1 3307 (22448), which recommends no discharges from Lake O into the St. Lucie River Estuary, for newly proposed Lake Okeechobee System Operating Manual (LOSOM).

Manatee Deaths Continue at Alarming Rate

An unprecedented 1000 manatees are expected to die this year, primarily due to a lack of sea grass in the Indian River Lagoon (IRL).

In our area, seagrasses have been decimated by due to discharges from Lake Okeechobee. Those discharges bring turbid fresh water and algal blooms, altering the salinity, poisoning the water and blocking the sunlight the seagrasses need to flourish.

Although Martin County is working with the Florida Fish and Wildlife Conservation Commission (FWC) and Florida Oceanographic Society (FOS) on Hutchinson Island to develop a seagrass planting strategy, efforts to replenish seagrasses in the IRL remain difficult due to continued discharges from Lake Okeechobee.

Please contact the Army Corps of Engineers and ask them to protect the IRL. and the people, plants and animals that live in and around it, by stopping the discharges from Lake O into the St. Lucie River Estuary.

Everglades Agricultural Area (EAA) Reservoir Construction to Begin

63% Reduction of Lake O Discharges into Rivers Predicted

On April 22, the South Florida Water Management District (SFWMD) Governing Board unanimously approved the Everglades Agricultural Area (EAA) Reservoir Agreement with the U.S. Army Corps of Engineers, allowing the Corps to begin construction of the reservoir this year. The project is expected to be completed in 2027.

Governor Ron DeSantis joined Florida Department of Environmental Protection (DEP) Secretary Noah Valenstein in Wellington to make the announcement. "Today marks a critical milestone for Everglades restoration and achieving our state's long-term environmental goals," said Governor DeSantis. "When I took office, I made expediting the EAA Reservoir Project a top priority. Signing this agreement means we are another step closer to moving more clean water south through the Everglades and reducing harmful discharges from Lake Okeechobee into the Caloosahatchee and St. Lucie estuaries."

The agreement was applauded by environmental groups across south Florida. This reservoir, combined with the state's three stormwater treatment areas, 6500 acres of manufactured marsh scheduled to be completed by SFWMD in 2023, will provide a 10,500 acre, 78.2 billion gallon reservoir, allowing clean water to be sent south into the Everglades and reducing Lake O discharges to the St. Lucie and Caloosahatchee rivers by a combined 63%.
